## DO'S & DON'TS

**WELCOME TO FOUNTAIN LAKE RV PARK:** We are an adult RV park in a natural setting. Feel free to enjoy our Park, nature trail, mini golf, pool tables, etc. Membership Leases are available. Inquire at office.

**QUIET HOURS:** 10:00p.m. - 8:00a.m. Let everyone enjoy this quiet rural setting.

**SPEED LIMIT: 9 mph** in the entire Park. Vehicles must be driven on established roadways.

**PARKING:** Park on your own site or in designated parking areas.

**DUMPSTER AND RECYCLING:** Located just inside the front gate.

**PETS:** Must be on a leash. No pets allowed in any Park buildings. CONTINUOUS BARKING will not be tolerated. Clean up after your pet. Pets are limited to (2) two per couple.

**CHILDREN:** Children under the age of 18 must have adult supervision when using mini golf, shuffleboard, pool tables, etc. Children under the age of 16 must have a guardian with them to drive a golf cart.

**LAUNDRY:** Located off the patio on the north side of clubhouse. You are on your honor to pay.

**LIBRARY:** Located behind kitchen in club house. You are welcome to borrow books.

**CAMPFIRES:** Permitted in approved fire pits only. Please be considerate of your neighbors.

**PROPANE:** LP gas is available, inquire at office.

**SEWER:** Connection from RV to sewer inlet must be sealed with a rubber gasket or other device. All RV's must be self-contained including destination trailers.

**WATER LINES:** Anti-siphon device is required on all water lines to your RV.

**ATV's and UTV's:** Not allowed on the property.

**MOTORCYCLE:** To be ridden in and out of Park only.

**PRIVACY:** Do not walk or drive across other lots.

**FIREWORKS:** Not allowed in the Park.
